Notice Pursuant to Section 708A(5)(e) of the Corporations Act

CropLogic Limited ("the Company") issued 73,985,020 fully paid ordinary shares on 24 December 2018. These shares were included in an Appendix 3B announcement to the Australian Securities Exchange ("ASX") released today.
