### Notice Pursuant to Section 708A(5)(e) of the Corporations Act

CropLogic Limited (“the Company”) issued 750,000 shares on 2 August 2019 and 8,262,500 shares on 6 August 2019. These shares were included in Appendix 3B announcements lodged with the Australian Securities Exchange (“ASX”) on 2 August 2019 and today.
